

TERMS AND CONDITIONS FOR ONTARIO ASSOCIATION OF VETERINARY TECHNICIANS "2023 RVT MONTH DAILY DRAWS"

Your participation in The Ontario Association of Veterinary Technicians (OAVTs) 2023 RVT Month Daily Draws ("The Daily Draws") shall be deemed to be your complete acceptance of the Terms and Conditions herein. The following are the Terms and Conditions of The Daily Draws:

- 1. Only persons over the age of 18 are eligible for entry to The Daily Draws. You may be asked, at any stage, to provide OAVT or a third party with proof of age and /or identity.
- 2. No purchase or payment at any time is necessary to enter or win.
- 3. The Daily Draws shall take place (October 1 to October 31, 2023).
- 4. The odds of being selected as a winner depend on the number of entries received. The winner will be randomly selected from the pool of entries.
- 5. In order to enter the contest, the entrant must be a member in good standing with the OAVT.
- 6. OAVT employees, sponsors, and affiliates' employees and their immediate family members are not eligible to participate.
- 7. Each entrant shall be entitled to make one (1) entry into The Daily Draws only. In the event that the OAVT deems an entrant to have made multiple applications to enter or to have acted in bad faith with respect to the Promotion, the entrant shall be excluded from The Daily Draws and consequently ineligible to win the Promotional Prize, as defined below.
- 8. The Prize for winning a daily draw shall be a \$50 digital gift card from a select list of available cards.
- 9. There is no substitute for their prize.
- 10. The winner must be an RVT in good standing (as defined by the OAVT) to continue to receive their prize.
